Pershing Rifles Fallen Brothers

Killed in action: Deaths resulting directly or indirectly from hostile action.

Killed in the line of duty: Deaths resulting from other than hostile action, such as aircraft accidents, training accidents, etc.

World War II

Second Lieutenant Oscar H. Alexis USA – Company A-2 (University of Nebraska) – Killed in action 25 June 1944, Montieri, Italy.

Second Lieutenant Robert M. Anderson USAAF – Company C-4 (Clemson University) – Killed in action on 13 January 1943 while serving with the 365th Bomb Squadron, 8th Air Force, when his B-17 bomber was shot down by German anti-aircraft fire over Lille, France.

Major Kenneth D. Bailey USMC – Company C-3 (University of Illinois) – Killed in action 26 September 1942, Guadalcanal. See also, Hall of Valor (**Medal of Honor**).

Technician Five Edward Billman USA – Company A-1 (Ohio State University) – Died of complications from pneumonia on 1 October 1944, in England.

Private First Class William E. Brookins USA – Company D-4 (later D-6/D-7/D-17) (Louisiana State University) – Killed in Action on 5 March 1945 while assigned to the 194th Infantry, 99th Infantry Division during Operation Market Garden.

Second Lieutenant John E. Carmichael, Jr. USA – Company D-4 (later D-6/D-7/D-17) (Louisiana State University) – Killed in Action 7 June 1944 on Utah Beach during the Normandy Invasion while assigned to the 22nd Infantry, 4th Infantry Division.

Second Lieutenant Howard C. Copeland USAAF – Company C-4 (Clemson University) – Killed in the line of duty on 6 February 1945 when the B-24 bomber he was piloting crashed in the Atlantic Ocean after taking off from Kindley Field, Bermuda, enroute to the Mediterranean.

Lieutenant William S. Devereaux USN – Company A-2 (University of Nebraska) – Killed in action March 1943, Russell Islands.

Captain Alan N. Dickson USA – Company C-2 (University of Wisconsin) Killed in action 21 Oct 1944 during the Battle of Leyte while serving with the 13th Engineer Battalion, 7th Infantry Division.

First Lieutenant Archibald C. Dudley USA – Company C-4 (Clemson University) – Killed in action 6 December 1944, after an opposed crossing of the Saar River near Pachten, Germany.

Major Leonard C. Dull USA – Company A-2 (University of Nebraska) – Died of Wounds sustained on or about 20 September 1944 while commanding the 2nd Battalion, 359th Infantry, 90th Infantry Division, during the Battle of Chambois that secured the breakout from Normandy.

Pershing Rifles Fallen Brothers

Ensign David S. Felsenthal USN – Company D-4 (later D-6/D-7/D-17) (Louisiana State University) – Missing and presumed killed in the line of duty while assigned to the air wing of the carrier *Saratoga* when his aircraft disappeared over the Coral Sea on 18 December 1942.

Major Glenn E. Fissell USMC – Company A-1 (Ohio State University) – killed in action by intense enemy direct fire on 13 November 1943 while trying to rescue a wounded marine during the Battle of the Coconut Grove on Bougainville, Solomon Islands. See also, Hall of Valor.

Second Lieutenant John B. Folsom, Jr., USAAF -- Company C-4 (Clemson University) – Killed in action when his B-17 bomber was shot down near Berlin, Germany, 6 August 1945.

First Lieutenant Wallace C. Forbush, Jr. USA – Company B-8 (Cornell University) – Platoon Leader in Company C, 894th Tank Destroyer Battalion. Killed in action by German tank fire at the Anzio beachhead, Italy, on 4 February 1944.

Second Lieutenant Wallace Hembrough USAAF – Company F-3 (University of Illinois-Chicago) – Killed in action on February 21, 1945, northwestern Germany.

Second Lieutenant Howard T. Hirschel USA – Company D-5 (later A-8) (City College of New York) – Killed in action 24 December 1944 while embarked on a troopship sunk by a German U-Boat.

Second Lieutenant Bernard Horowitz USA – Company D-5 (later A-8) (City College of New York) – Killed in action.

Captain John E. Jarmin USA – Company A-2 and NHQ, (University of Nebraska) – Killed in action on 14 March 1943 while serving with the 17th Infantry, 7th Infantry Division during the battle of Attu, Aleutian Islands, Alaska—the only modern land battle ever fought on U.S. territory. Jarmin Pass, site of the heaviest fighting, is named in his memory. National Commander 1936-37. See also, Hall of Valor.

First Lieutenant Eugene F. Jehlik USA – Company C-3 (University of Illinois) – Killed in action on 28 November 1942 while serving as a tank commander near Tunis, Tunisia, during the North African Campaign.

First Lieutenant Robert Gehle Jobe USAAF – Company F-1 (Ohio University) – Killed in action over Altenkirchen, Germany 22 February 1944.

First Lieutenant Howard C. Katz USA – Company D-5 (later A-8) (City College of New York) – Killed in action.

Second Lieutenant Charles W. Kessler USA – Company D-4 (later D-6/D-7/D-17) Louisiana State University) – Killed in action on 14 June 1944 during the breakout from the Normandy Beachhead while assigned to the 357th Infantry, 90th Infantry Division.

First Lieutenant Brian L. Kethley, Jr. USAAC – Company D-4 (later D-6/D-7/D-17) (Louisiana State University) – Missing and presumed Killed in Action when his P-51 fighter was destroyed by the effects of a secondary explosion during a bomb run on Hong Kong Harbor.

First Lieutenant George S. Koushnareff USA – Company D-5 (later A-8) (City College of New York) – Died of wounds 16 November 1942, North Africa.

First Lieutenant William H. Kranebrink USMC – Company C-5 (later A-15, C-8) (University of Maryland) – Killed in action on 22 July 1944 while serving with Company C, 1st Battalion, 21st Marines, 3rd Marine Division, during the Battle of Guam.

Pershing Rifles Fallen Brothers

Major Robert A. Lane USA – Company A-1 (Ohio State University) – Killed in action on 23 August 1944 near Conche, France, during the breakout from Normandy while assigned to Combat Command B, 2nd Armored Division.

Major Robert C. Maze USMC – Company G-10 (University of California at Los Angeles) – Killed in Action while Commanding Marine Fighting Squadron 511 (VMF-511) when his F4U Corsair was downed by anti-aircraft fire over the Pacific off Okinawa, 27 May 1945.

Second Lieutenant John D. McArthur, Jr. – Company C-4 (Clemson University) – Killed in action on 20 February 1945 when the Belgian troopship on which he was embarked was torpedoed by a German submarine off Cherbourg, France while carrying reinforcements from the 262nd Infantry, 66th Infantry Division to the Battle of the Bulge.

First Lieutenant William T. McCoy USAAF – Company C-4 (Clemson University) – Missing and presumed killed when his P-40 fighter failed to return from a mission over Tangchung, China, on 10 October 1943. Lt. McCoy was assigned to the 25th Fighter Squadron, 51st Fighter Group, 10th Air Force.

Captain Richard E. Miller USAAF – Company A-3 (Indiana University) – Killed in action when his B-26 bomber was destroyed by anti-aircraft fire over Italy on 22 January 1943.

First Lieutenant Eugene M. Nettles USA – Company D-4 (later D-6/D-7/D-17) (Louisiana State University) – Killed in Action on 26 April 1945 during a firefight following a crossing of the Danube River near Kapfelberg, Germany, while assigned to Company B, 261st Infantry, 65th Infantry Division. See also, Hall of Valor.

First Lieutenant Lee D. O'Brien USA – Company D-5 (later A-8) (City College of New York) – Died of wounds suffered on or about 14 January 1945 near Baclain, Belgium, while serving with Company F, 36th Armor, 3rd Armored Division.

First Lieutenant John H. Osborne USA – Company C-4 (Clemson University) – Killed in Action by artillery crossfire 10 February 1944 during fierce fighting while crossing the Rapido River, south of Monte Cassino, Italy, with the 141st Infantry, 36th Infantry Division.

First Lieutenant Richard T. Osteen Jr. USAAF – Company C-4 (Clemson University) – Killed in action on 8 August 1944 when his B-17 bomber was shot down during a low-level bombing run near Caen, France.

Second Lieutenant Henry L. Pelzer USA – Company B-2 (University of Iowa) – Missing and presumed killed in action on 4 January 1945 while serving with the 69th Tank Battalion, 6th Armored Division, when his tank took a direct hit near Bastogne, Belgium, during the Battle of the Bulge.

Captain Charles W. Stevenson USAAF – Company A-1 (Ohio State University) – Killed in action on 19 September 1944 when his C-47A transport was shot down during an airborne assault over Holland during Operation Market Garden.

Second Lieutenant Victor J. Sutker USA – Company D-4 (later D-6/D-7/D-17) (Louisiana State University) – Killed in action on 10 July 1944 during fierce fighting at Laiatico, Italy, while assigned to the 351st Infantry, 88th Infantry Division.

First Lieutenant John W. Tunnell USMC – Company E-5 (later B-8) (Cornell University) – Missing and presumed killed in action after bailing out over the Pacific Ocean after his TBF-1 Avenger fighter was shot down during a strike on Kahili Airfield, Bougainville, Solomon Islands, on 4 November 1943.

Pershing Rifles Fallen Brothers

Captain John Z. Wheeler USA – Company E-2 (University of Minnesota) – Missing and presumed to have died while confined to a Japanese prison ship mistakenly attacked and sunk by friendly forces on 26 January 1945. See also, Hall of Valor.

First Lieutenant Hugh W. Wylie USA – Company A-1 (Ohio State University) – Killed in action on 17 September 1944 during Operation Market Garden near Arnhem, Holland, while serving with Battery A, 376th Parachute Field Artillery Battalion, 82nd Airborne Division. The indoor shooting range at Ohio State is named in his memory.

Captain Ralph A. Wilmot USA – Company C-3 (University of Illinois) – Captured by German forces on or about 23 December 1944 while assigned to the 634th Anti-Aircraft Artillery Battalion during the Battle of the Bulge. Missing and presumed to have died in captivity while a German prisoner of war.

Korea

First Lieutenant James G. Hickerson USA – Company C-4 (Clemson University) – Died on 29 January 1951 of wounds received on 28 January 1951, Pusan Perimeter, Korea.

Second Lieutenant James J. Kiernan USA – Company D-8 (Fordham University) – Killed in action 18 August 1952, North Korea.

First Lieutenant (posthumously Captain) C. Edward Schiele USA – Company D-4 (later D-6/D-17) (Louisiana State University) – Killed in action by sniper fire during the Battle of Heartbreak Ridge, North Korea, on 3 January 1952 while serving as company commander of Company K, 31st Infantry, 7th Infantry Division.

Vietnam

First Lieutenant Robert H. Aldrich USMC – Company Q-5 (Pennsylvania Military College) – Killed in the line of duty 27 December 1971 when his helicopter crashed into the sea off the coast of Vietnam.

Second Lieutenant Jesse Rutledge Baker USMC – Company C-4 (Clemson University) – Killed in action 18 August 1967, near Da Nang.

First Lieutenant William J. Brewer, Jr. USA – Company R-1 (Eastern Kentucky University) – Killed in action, 14 May 1970, while serving with the 2nd Squadron, 7th Cavalry, 1st Cavalry Division. Tay Ninh Province.

First Lieutenant William D. Bridge USA – Company D-1 (University of Dayton) – Killed in action 16 June 1970 while serving with H Troop, 17th Cavalry, 198th Light Infantry Brigade. Quang Ngai Province.

Captain Patrick J. Brophy USA – Company O-5 (Gannon College PA) Killed in Action 1 October 1967 when his helicopter crashed near Pleiku while serving as S3 Air, 1st Battalion, 12th Infantry, 4th Infantry Division.

Major Anthony J. Brouillon USA – Company Q-8 (Hofstra University) – Killed in the line of duty 8 September 1969 while serving as Advisor to the 4th Battalion, 25th ARVN Division, Long An Province, Vietnam.

Pershing Rifles Fallen Brothers

Captain Alvin K. Broyles, Jr. USA – Company R-4 (East Tennessee State College) – Killed in action on 28 April 1965 while serving as a regimental advisor to the Army of South Vietnam. Vinh Long Province. See also, Hall of Valor.

First Lieutenant (later Captain) Lorenza Conner USAF – Company P-4 (Tuskegee University) – Killed in action over North Vietnam on 27 October 1967 when his F-4D Phantom II fighter was hit by anti-aircraft fire and the ejection seat failed to operate.

Major Roy E. Congleton USA – Charter Member of Company L-4 (North Carolina State University) – Killed in action 21 December 1964 during an ambush while serving as an advisor to the South Vietnamese Army.

Major Edward W. Crum USA – Company C-3 (University of Illinois – later transferred to the United States Military Academy) – Killed in action by enemy mortar fire near Chan Doe City, Kien Phong Province, on 6 February 1968, during the Tet Offensive, while serving as senior advisor and G3 advisor to the Vietnamese 44th Special Tactical Zone.

Second Lieutenant William E. Davis, Jr. USA – Company N-4 (North Carolina A&T University) – Killed in action from fragmentation wounds received while serving with Company C, 2nd Battalion, 18TH Infantry, 1st Infantry Division, 10 December 1965. Vietnam.

First Lieutenant Frank Cesare Deusebio USA – Company D-8 (Fordham University) – Killed in action 18 March 1968.

Major Myron F. Diduryk USA – Company N-8 (St. Peter's College) – Killed in action by sniper fire on 24 April 1970, while S3, 2nd Squadron 12th Cavalry, 1st Cavalry Division, Phouc Long Province. See also, Hall of Valor.

First Lieutenant Gary Dennis Fernandez USA – Company Q-8 (Hofstra University) – Killed in action 7 January 1968, Binh Duong Province.

First Lieutenant Raymond Joseph Flynn, Jr USA. -- Troop L-1 (University of Toledo) – Killed in action 17 December 1970 from wounds received 2 December 1970 while piloting a helicopter near Ba Xugen Province.

Captain Eugene D. Franklin USA – Company R-4 (East Tennessee State College) – Killed in action on 24 June 1965 leading a counterattack while serving as advisor to an embattled South Vietnamese infantry battalion. See also, Hall of Valor.

Private First Class Galen Dean Grethen USA – Company G-2 (Iowa State University) – Killed in action 16 April 1966 while serving as a combat medic with the 101st Airborne Division near Phan Thiet.

First Lieutenant John Charles Hauschmidt USAF – Company F-3 (University of Illinois-Chicago) – Killed in action 5 October 1965, near Tuy Hoa.

First Lieutenant John Robert Hagood USA -- Company A-2 and National Headquarters (University of Nebraska) – Killed in action 1 November 1969, Quang Binh.

Captain Thomas T. Hewitt USA – Company E-7 (University of Kansas) – Killed in Action 2 July 1970, Thua Thien Province, while directing the defense of Hill 902 as Commander of Company C, 2nd Battalion, 506th Infantry, 101st Airborne Division.

Captain Richard J. Hock USA – Company F-1 (Ohio University) – Killed in the line of duty 16 January 1972 as a result of a helicopter crash, Thua Thien Province.

Pershing Rifles Fallen Brothers

First Lieutenant Richard Douglas Hogarth USA – Company D-1 (University of Akron) – Killed in action 6 May 1966, Binh Dinh Province, while serving as a platoon leader in Company A, 7th Cavalry, 1st Cavalry Division.

First Lieutenant Vassar W. Hurt III USA – Company B-15 (later O-4) (Virginia State University) – Died of wounds 2 May 1970, Quang Tri.

Captain John J. Kalen USA – Company A-12 (Northeastern University) – Killed in action, 16 September 1969 when his OH-6A helicopter was shot down on a low-level reconnaissance mission near Pleiku while serving as a commander of Company A, 2nd Battalion, 8th Infantry, 4th Infantry Division.

Second Lieutenant Orville E. Kitchen Jr. USA – Company B-1 (University of Dayton) – Killed in action 2 April 1970 while serving as a field artillery forward observer with Company B, 2nd Battalion, 27th Infantry, 25th Infantry Division, while on a rapid reaction mission to rescue a pinned-down ranger patrol.

Sergeant Sanford J. Ledbetter USA – Company D-7 (University of Arkansas) – Killed in action 27 Aug 1969 when his tank was hit by enemy fire while assigned to the 2nd Squadron, 1st Cavalry, 4th Infantry Division. Binh Thuan Province.

First Lieutenant Phillip Lewis Lee USA – Company A-1 (Ohio State University) – Mortally wounded on 17 April 1971 while serving with Troop F, 2nd Squadron, 11th Armored Cavalry, as it defended against an ambush in Binh Doung Province, Vietnam. Died of wounds on 17 June 1971.

Major David R. Mackey USA – Company B-3 (Western Kentucky State University) – Killed in the line of duty while serving as S3 of the 5th Battalion, 60th Infantry, 9th Infantry Division, when his UH-1 command and control helicopter was involved in a mid-air collision with an AH-1 gunship over Long An Province.

First Lieutenant Terry Lee Manz USA – Company D-2 (University of Wisconsin-Milwaukee) – Killed in the line of duty 28 January 1967 when his UH-1D helicopter was hit by friendly artillery fire.

Major Antonio M. Mavroudis USA – Company A-8 (City College of New York) – Killed in action, 28 October 1967, Quang Tin Province. See also, Hall of Valor.

Captain Fred Howell McMurray, Jr. USA – Company C-4 (Clemson University) – Missing and presumed killed in action on 7 April 1968, when his OH-13 helicopter was shot down during a low-level aerial reconnaissance mission over the A Shau Valley, Thua Thien Province.

First Lieutenant James A. Merrett USA – Company D-10 (Arizona State University) – Killed in action 12 December 1968, Hau Nghia Province.

First Lieutenant Emery George Mikula USA – Company N-8 (St Peter's College) – Killed in action 13 October 1966 after completing a medical assistance mission in Binh Duong Province while serving as a Civil Affairs Officer with the 173rd Airborne Brigade.

Stephen H. Miller – Squadron A-15 (later Company C-8) (University of Maryland) – Executed by the Viet Cong on 7 February 1968 during the Tet Offensive in Hue, Vietnam while serving as a Department of State Foreign Service Officer with the Joint US Public Affairs Office.

Major Billy Joe Nave USA – Company R-4 – (East Tennessee State College) – Killed in the line of duty on 27 June 1966 while serving as commanding officer of Troop C, 1st Squadron, 9th Cavalry, 1st Cavalry Division. Major Nave's UH-1B helicopter was involved in a mid-air collision at Tuy Hoa Air Base, Phu Yen Province, that resulted in the loss of all aboard both aircraft.

Pershing Rifles Fallen Brothers

Captain Michael R. Odum USA – Company M-6 (later M-16) (Florida State University) – Killed in action 11 September 1969, Phong Dinh Province.

Captain Christopher J. O'Sullivan USA – Company D-8 (Fordham University) – Killed in action 30 May 1965 while leading a counterattack against a superior enemy force. Quang Ngai Province. See also, Hall of Valor.

Captain (posthumously Major) Eugene M. Pabst USAF – Company D-8 (Fordham University) – Missing and presumed killed in action after his F-4C Phantom fighter jet failed to recover from a dive during an attack run over Southeast Asia on 7 October 1966. See also, Hall of Valor.

Major Allen Pasco USA – Company A-8 (City College of New York) – Killed in action, 6 July 1968, Binh Thuan Province.

First Lieutenant Michael Peterson USA -- Troop L-1 (University of Toledo) -- Killed in action 24 October 1970, Phuoc Tuy Province.

Captain Riley Leroy Pitts USA – Company F-7 (Wichita State University) – Killed in action 31 October 1967 while commanding Company C, 2nd Battalion, 27th Infantry, 25th Infantry Division during an airmobile assault near Ap Dong, Binh Duong Province, Vietnam. See also, Hall of Valor (**Medal of Honor**).

First Lieutenant Robert Thomas Rice, Jr. USA – Battery G-1 (Xavier University) – Killed in action 8 August 1970, near Pleiku.

First Lieutenant Layne J. Romagosa USA – Company D-6 (later D-7/D-17) (Louisiana State University) – Killed in action on 21 September 1970 from the effects of a Chinese claymore mine while leading a platoon from Troop B, 1st Battalion, 12th Cavalry, 1st Cavalry Division near Bien Hoa, Vietnam. See also, Hall of Valor.

First Lieutenant Gregory C. Schoper USA – Company C-4 (Clemson University) – Killed in action 14 February 1970, Tay Ninh.

Second Lieutenant Gary Arnold Scott USA – Company F-8 (Syracuse University) – Killed in action 29 March 1968, during the Battle of Hue.

Captain Robert Wilbur Smith USAF – Squadron A-15 (later C-8) (University of Maryland) – Killed in action 17 April 1970 when his F-4 fighter jet crashed during a close air support mission over Binh Dinh Province.

Captain Charles F. Thomas IV USA – Company B-3 (Western Kentucky State University) – Killed in action 8 April 1971 as a result of rocket and mortar fire while serving with the 3rd Battalion, 319th Field Artillery, 173rd Airborne Brigade. Binh Dinh Province.

First Lieutenant Paul W. Wahler Jr. USA – Company C-2 (University of Wisconsin) – Killed in the line of duty on 18 November 1967 while assigned to the 14th Engineer Battalion, 18th Engineer Brigade. Kanh Hoa Province, Vietnam.

First Lieutenant David B Wainwright USA – Company F-7 (Wichita State University) – Killed in action 4 October 1967, as pilot of a medical evacuation helicopter that crashed in bad weather while attempting to extract wounded soldiers near Tuy Hoa.

Captain Robert D. Walden USA – Company C-4 (Clemson University) – Killed in the line of duty, 15 March 1970, while protecting his troops from the effects of an ammunition fire.

First Lieutenant Paul W. Wahler, Jr. USA – Company C-2 (University of Wisconsin) – Killed in the line of duty on 18 November 1967 from the effects of a vehicle crash while serving with the 14th Engineer Battalion, 45th Engineer Group, Kanh Hoa Province, Vietnam.

Pershing Rifles Fallen Brothers

First Lieutenant Sterling A. Wall USA – Company A-12 (Northeastern University) – Killed in the line of duty as the result of a helicopter crash, 24 August 1967, Pleiku Province.

Captain Gerald J. Winch USA – Company M-1 (John Carroll University) – Killed in Action on 15 March 1968 while assigned to the 1st Battalion 27th Infantry, 25th Infantry Division, in close combat during the Tet Offensive. Binh Duong Province.

Captain John F. Young USA – Company A-8 (City College of New York) – Killed in action, 16 January 1968, An Giang Province.

Afghanistan

Sergeant Gregory Owens Jr. USA – Company Q-17 (Prairie View A&M University) – Killed in action, 20 July 2009, from the combined effects of an improvised explosive device and ground attack near Maydan Shahr.

Second Lieutenant Justin Sisson USA – Company M-16 (Florida State University) – Killed in action, 3 June 2013, by a suicide bomber near Tsamkani.

Iraq

Second Lieutenant Jeffrey C. Graham USA – Company C-1 (University of Kentucky) – Killed in action, 19 February 2004, from the effects of a bomb blast as warned his platoon of an impending attack near Kalidiyah.

Captain Matthew C. Mattingly USA – Battery G-1 (Xavier University) – Killed in action 13 September 2006, Mosul.

Captain Jonathan D. Grassbaugh USA – Company E-8 (later T-8) (Johns Hopkins University) – Killed in action 7 April 2007 by an improvised explosive device near Zaganiyah.

First Lieutenant Ryan Patrick Jones USA – Company E-12 (Worcester Polytechnic Institute) – Killed in action 2 May 2007 from the effects of a roadside bomb; Baghdad.

First Lieutenant Michael L. Runyan USA – Battery G-1 (Xavier University) – Killed in action 21 July 2010, from the effects of an improvised explosive device; Muqdadiah.

Captain Kafele H. Sims USA – Company G-8 (Howard University) – Killed in the line of duty 16 June 2009, Mosul.

Other

Major Leon Andrews USAF – Company D-4 (later D-6/D-7/D-17) (Louisiana State University) – Killed in the line of duty on 27 October 1950 when his aircraft went down over Lake Pontchartrain, Louisiana, during heavy pre-dawn fog.

Major Arthur B. Barrows USMC – Company A-1 (Ohio State University) – Missing and presumed killed in the line of duty when an R4D-1 aircraft, on which he was a passenger, disappeared off the coast of Alaska on 16 August 1942.

Pershing Rifles Fallen Brothers

Ensign Robert J. Crossan USN – Company C-12 (Massachusetts Institute of Technology) – Killed in the line of duty near Corpus Christi, Texas, during Navy pilot training, 28 December 1978.

Lieutenant (jg) Robert Dale Fontenot USN – Company D-6 (later D-17) (Louisiana State University - later transferred to the U.S. Naval Academy). Killed in the line of duty near Corpus Christi, Texas, during Navy pilot training, 17 January 1955.

Colonel Robert J. Kelly USA – Company A-12 (Northeastern University) – Killed in the line of duty as a result of a helicopter crash while serving as Assistant Chief of Staff G2, Hq V Corps; 23 February 1993, Weisbaden AB, Germany.

Second Lieutenant Richard W. Martin USA – Company A-1 (Ohio State University) – Killed in the line of duty on 29 January 1943 when the truck in which he was riding overturned on a bridge and plunged into a stream during training at Camp Atterbury, Indiana.

Cadet Robert A. Nelson USAAF – Company A-2 (University of Nebraska) – Killed in the line of duty during pilot training, 28 April 1941.

Ensign Brooks L. Potter USN – Company A-2 (University of Nebraska) – Killed in the line of duty in an aircraft accident near Seattle, WA, 24 May 1944.

Second Lieutenant Richard O. Snow USAAF – Company A-1 (Ohio State University) – Killed in the line of duty on 1 July 1945 when his B-29 bomber was struck by lightning during a training flight over Benton, Kentucky.

Second Lieutenant Kenneth F. Tempero USA – Company A-2 and National Headquarters (University of Nebraska) – Killed in the line of duty near Eglin AFB, FL, while undergoing Army Ranger training, 1961. National Commander, 1960-61.

Major John E. Vogel USAAF – Company A-1 (Ohio State University) – Killed in the line of duty on 29 September 1945 when his fighter aircraft crashed on Okinawa.

Captain Robert A. Yates USAF – Company E-8 (New York University) – Missing and presumed killed in the line of duty when his RB-57F reconnaissance aircraft disappeared over the Back Sea near Odessa, Soviet Union, on 14 December 1965, presumably from a Soviet surface-to-air missile strike.
